Camp Seale Harris is a comprehensive diabetes support program that served a total of 2246 people in 2018 including 665 children with diabetes ages 0-19 in 16 different program sites located throughout Alabama and North Florida. Program service sessions included: 7 overnight residential camps, 5 day camps, and 13 community day events teaching children and families how to live well with diabetes. Participants received structured health education by volunteer physicians, nurses, and other diabetes healthcare professionals and peer counselors. Children's and teen camps taught diabetes care skills and provided full medical oversight including diabetes medications and supplies. Family camps and support events provided diabetes education, peer networking, and general emotional support. Outcomes included
